Insolroll Interior Solar and Roller Shades are warranted for defects in materials and workmanship for a period of ten (10) years from date of manufacture. The ten (10) year warranty applies to fabrics, clutch operators, spring operators and accessories. All motor, electrical switching and control components are warranted for a period of five (5) years from the date of manufacture.

This warranty does not cover any product, which fails due to accident, alterations, misuse, abuse, neglect, acts of nature, improper handling, installation or maintenance of the product or failure to follow instructions for installing or operating the product. Insolroll does not warrant against freight damage.

Warranty excludes damage due to exposure to salt water, gradual fading due to UV degradation and normal wear. The warranty does not apply to fabric damage resulting from improper cleaning or maintenance.

Insolroll does not warrant against fading or degradation of digitally printed images.

The Insolroll warranty is valid only for products owned by the original end user and installed in the original location. At its option, Insolroll will repair or replace any product which fails to conform to this warranty. This shall be the sole remedy of the buyer under this warranty. In no event shall Insolroll be liable for transportation costs to return the product, costs of removal or reinstallation of the product or incidental or consequential damages. Insolroll's Limited Lifetime Warranty is available for commercial projects only that are registered and approved by Insolroll at time of quotation. For residential applications or non-registered commercial applications Insolroll's Ten Year Limited Warranty applies.

The lifetime warranty applies to fabrics, clutch operators, spring operators and accessories. For purposes of this warranty the Lifetime of the product is defined as no longer than twenty-five (25) years. All motor, electrical switching and control components are warranted for a period of five (5) years from the date of manufacture.

This warranty does not cover any product, which fails due to accident, alterations, misuse, abuse, neglect, acts of nature, improper handling, installation or maintenance of the product or failure to follow instructions for installing or operating the product. Insolroll does not warrant against freight damage.
